# Minutes of the Parish Council Meeting held on Tuesday 10<sup>th</sup> September @ 7pm in the Green Room, Ashton under Hill

- 1. The Chair welcomed Cllrs, there were no members of the public
- 2. Declarations of Interest:

It stresses that further criteria will need to be applied before the sites are proposed for allocation. The map, SWDPR Interactive Polices Map, which is also to be found on the same website page, shows all the sites originally submitted and does not show which ones have been eliminated.

As a member of the Joint Advisory Panel I have been consulted on the sites which are still being considered as allocations. They will be published in the consultation draft of the revised SWDP which will be presented in the autumn. These are confidential at the moment.

It should be noted that there are only two sites in Ashton included in the SHELAA but I cannot comment on whether or not either will be brought forward.

#### Piper Homes Development, Elmley Road

I attended a site meeting at the Piper Homes site opposite Bredon Hill Academy to consider the safety of the proposed pedestrian access to the new development. The Highway Authority had required a safety audit which found that the approved pedestrian access was not safe and would therefore have to be changed. The meeting was due to be attended by the case officer, two representatives of Worcs CC Highways team and the developer. I also requested that a representative of the Parish Council should be allowed to attend, and since no councillors were available, Roger Umpleby came. You will have seen his very full report.

Since the new proposal will remove a substantial portion of hedge and three trees, contrary to the approved Landscape Plan, a revised planning application will have to be submitted. You will be asked to comment on this, but I think that what is suggested is the least unsatisfactory solution.

Cllr Darby stated the management company would be responsible for the maintenance of the new hedge. The PC will have a chance to propose what hedging should be planted once Wychavon have issued the modified planning application.

You will have seen the appeal against Wychavon's refusal of a Rural Worker's dwelling at the Pig Barn, the Groaten has been refused.

No further development on Willow Cottage to report on.

- a. Social Centre no report. Grant application received for 2019/20. PC have issued an invoice for the ground rent dating back to 1967
- b. Bredon Hill Conservation Group meeting October 2019. Eckington 25 unit dwelling for affordable housing. Gypsy site in Eckington to expand the site from 2-7. Action MW
- c. PACT meeting with West Mercia. Action KR
- d. Lengthsman hedge next to the war memorial has been cut back. DC agreed to talk to Stonecroft regarding the overhanging hedge. Check drains in the village. Action SH/DC
- e. Vehicle Activated Sign, agreed to go ahead with the proposal as per SH email. First School are producing "reduce your speed posters" will laminate chosen few and put up around the village, agreed to issue medals for the chosen ones.
- f. Flooding, reported drains outside the Mote house, SH has taken photos of flooded area, WCC say there is no issue, will report to AH. Lengthsman to inspect drains in the village
- g. Highways & Byways. The following street signs are damaged and in need of replacing (Bakers Lane, Elmley Rd & Willow Close ). No news on the entrance to Long Carrant Park from Highways, suggested that residents report it next time there is an accident.
- h. Trees in the Parish. Two ash trees and two Hornbeam have died and need to be removed at a cost of £360, two more quotes required. Need to replant in Dec/January. Agreed that the quote would be accepted via email and an order placed.
